
## TRACT 32576 - Lafourche Parish, Louisiana



## TRACT 32577 - Plaquemines Parish, Louisiana

All of the lands now or formerly constituting the beds and bottoms of all water bodies of every nature and description and all islands and other lands formed by accretion or reliction, except tax lands, owned by and not under mineral lease from the State of Louisiana on June 14, 2000, situated in Plaquemines Parish, Louisiana, within the following described boundaries: Beginning at a point having Coordinates of X = 2,556,100.00 and Y = 253,651.48; thence North approximately 10,530 feet to the right descending bank of the Mississippi River; thence Southeasterly along the said right descending bank of the Mississippi River to a point having a Coordinate of X = 2,565,100.00; thence South approximately 5,100 feet to a point having Coordinates of X = 2,565,100.00 and Y = 253,651.48; thence West 9,000.00 feet to the point of beginning, containing approximately **20 acres**, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927 (South Zone).
